How does my gift help?

Your gift to the Northeast Iowa Food and Fitness Initiative Endowment is invested and grows forever to support the mission of the Northeast Iowa Food and Fitness Initiative (FFI).

How is my fund directed?

The leaders of FFI use annual endowment distributions to start signature projects, cushion economic challenges, and advance their work in a strong way in the community.

How do endowments work?

Endowments are invested by our professional wealth managers in a diversified portfolio. Endowments pay out up to 5% annually. The remainder is reinvested to ensure that funds exist into perpetuity.

How do I make a gift?

We welcome gifts at any time and accept cash as well as stocks, bonds, IRAs, and gifts of grain or livestock.

Donors may name and honor or remember friends and family through their gifts or name the endowment in their will to create a legacy that will forever benefit the community.

What is Endow Iowa?

Endow Iowa is a 25% state tax credit for gifts to endowed funds. Upon receipt of your gift to the Northeast Iowa Food and Fitness Initiative Endowment, you will receive a voucher that can be used the same as cash to pay your state tax. Gifts up to \$1.2 million per individual or \$2.4 million per couple are eligible for Endow Iowa each year.
