History

<u>The NEI Food and Fitness Initiative</u> convened Community Foundation leaders from Allamakee, Winneshiek, Clayton, Fayette, Howard, and Chickasaw Counties in 2008; and provided financial support for the emerging network. County Representatives have met quarterly since 2009 to build a regional network of funders to address issues and leverage funding to benefit all participating counties.

<u>Six member counties</u> pay dues and provide representation and leadership to build the network.

2013 Philanthropic Advisor Grants

In 2013, \$6K in grants supported philanthropic advisor visits by Betty Steege and Jim Anderson to attorneys, bankers, wealth managers, and tax advisors in Allamakee, Clayton, Fayette, and Winneshiek Counties.

These grants are matched by the host foundations, leveraging \$6K in 2013. The impact has been increased awareness of community foundations, grants, Endow lowa 25% state tax credit and endowment growth. Through leadership provided by the Winneshiek County Community Foundation, the Philanthropic Advisors helped convene a regional conference for attorneys, wealth managers, tax advisors, and community members at NICC.

2013 NEI Food Hub Grant

A \$6K grant in 2013, and another \$6K grant approved for 2014 has supported the start-up of the NEI Food Hub. Goals accomplished include:



- Start a blue collar workplace CSA
- Develop a business plan for the Northeast Iowa Food Hub
- Online CSA program established
- Pilot distribution strategy for local healthy foods in retail establishments
- Establish a 501c3 non-profit structure
- Establish a board for the 501c3
- Explore programming that gets local healthy food to vulnerable populations.

The NEIFN has supported the work of Food Hub Manager Nick McCann and has leveraged more than \$105K in investment from USDA, Convergence Partnership, the Leopold Center and others.

Past Grants

Cross-Age Teaching Folios – a classroom project linking local food lessons to 1400 students, leveraging \$18K from partner funders

Food Value Cain Coordinator – a \$9.7K grant to support technical assistance and marketing expertise for local growers and producers.
